AFL \$75K Friday Payday Promotion 2018 Terms and Conditions

The following Terms and Conditions will be published on TABtouch (tabtouch.com.au/win).

- 1. Entry into the promotion is deemed acceptance of the terms and conditions set out in this document ('Terms and Conditions').
- 2. The promoter is Racing and Wagering Western Australia (RWWA) (ABN: 21 347 055 603) of 14 Hasler Road, Osborne Park WA 6017 (Promoter).
- 3. The '\$75K Friday Payday' promotion is valid for Rounds 1 4 of the AFL Season 2018.
- The promotional period commences at 8.00AM (WST), Monday 19 March 2018 and ends at 11.59pm (WST) Friday 13 April 2018. The promotion period for the first four (4) rounds of the AFL season within the promotional period:
 - a. Round 1: Commences at 8.00AM (WST), Monday 19 March 2018 and ends at 11.59pm (WST), Friday 23 March 2018
 - b. Round 2: Commences at 8.00AM (WST), Monday 26 March 2018 and ends at 11.59pm (WST), Friday 29 March 2018
 - c. Round 3: Commences at 8.00AM (WST), Tuesday 3 April 2018 and ends at 11.59pm (WST), Friday 6 April 2018
 - d. Round 4: Commences at 8.00AM (WST), Monday 9 April 2018 and ends at 11.59pm (WST), Friday 13 April 2018
- 5. Entry Criteria:
 - To be eligible to enter the '\$75K Friday Payday' Promotion, customers must place a valid
 Fixed Odds Singles bet to the value of \$20 or more on the Friday AFL game in Rounds 1 4
 with a TABtouch account or at any TAB retail outlet in WA during the promotion period.
 - b. TABtouch Account Customers: Eligible customers will automatically receive one (1) entry per person per ticket per bet type per Round into the promotion.
- 6. TAB Retail Customers:
 - a. Eligible customers will receive one (1) entry per person per ticket per bet type per Round into the promotion once they enter their Ticket Numbers (located on the ticket) and SMS their full name (first and last name) and ten digit Ticket Number (located on the ticket) to 0400 690 690.
 - b. Only one name and ten digit ticket number per SMS.

 - b. The one thousand (1,000) \$50 cash prize winners will be notified via SMS. Account customers not opted in for SMS marketing will not be notified.
