The following Terms and Conditions will be published on TABtouch (tabtouch.com.au/win).

- 1. Entry into the promotion is deemed acceptance of the terms and conditions set out in this document ('Terms and Conditions').

- 4. Entry Criteria:

- 5. Mystery Bets valid subject to pre-sale opening times.
